

Dear Mr. Young,

I am writing this letter to describe to you my despair over this entire mess at Booker T. MS 54. I think at this point it does not matter what I say. No one, absolutely no one, is listening. All of this started with my request for information from Pat Romandetto about missing money from the MS 54 allocations. I also requested a respite from the terrible harassment I have endured from Larry Lynch, prosecutable to the full extent of the law, and, with the additional closed books from me and the PTA, countless violations of the A-660s and "The Blue Book". After I sent the letter to Mrs. Romandetto I gave both Larry and Marie copies. They copied the grievance for two parents who have started a campaign of vengence and hatred which has left me stunned and devastated. The grievance should have remained confidential until the information I requested was given. But, it was not.

Totally unaware of the distribution of the grievance to the two parents and the resulting hate campaign started by them, I gave to the school a flyer announcing the final PTA meeting for the year, June 7. Larry Lynch did not allow these flyers to be distributed. I know no one who received one. At this meeting the two parents who had read the grievance told the few parents who were there at their invitation, including the OPAE representative DJ Shephard, that there were going to be massive lawsuits filed against each and every parent because of my grievance, and the shouting began. No one wanted me to say anything in my defense. The shouting and verbal abuse got so horrendous - even by DJ, who kept repeating over and over "resign, resign, resign"- that I got up and left, telling all there that "ok, I'm leaving". Everyone took that as "ok, I'm resigning", and DJ proceeded to urge all there to disassociate themselves from me, write Mrs. Romandetto and her with their alienation, and then set up a new PTA with a new President. All in violation of our own Bylaws, which state that any resignation must be in writing - I guess as a protection against this very thing from happening. Very bizarre.

The hatred, desire for revenge, and vindictiveness started by these two parents and aided and abetted by DJ Shephard, all because I filed a grievance against Larry Lynch and Marie Williams which I still feel was justified, was fanned out to the parents at Booker T. I was sent hate email; friends of mine were sent deplorable emails and a party was crashed so that I could be "forced" to hold another PTA meeting. No one, not one person out of this group, cares to know anything about what is in my grievance.

Then I faxed you a request to attend the special PTA meeting on June 25th, because I saw how this escalating hatred would spiral out of control, leaving resentment and a war dividing the parents at Booker T.

When we spoke monday afternoon the 25th of June I laid all the questions in my mind at your feet. I had every reason to believe that the meeting that night would be the

worst experience of my life, with people taking sides and saying things that not only would they regret, but would have lasting and divisive consequences for everyone there and the school. I asked you to come to this meeting to control the mob and allow all of us a chance to be a community once again. I wanted the meeting to put a stop to the hatred by not allowing any discussion of me, but an overview of the process of grievances. You told me to trust you.

The meeting began with the mob throwing my agenda in the garbage, because the group that was there was totally not interested in hearing anything about grievances against Larry. They wanted my blood. They wanted me to suffer. And they succeeded. Larry Lynch stood up and yelled that I was a liar, Jose Valerio spoke about how I called his house and told his daughter that I would attack him for going against me and he added that he had written a letter to DJ describing the telephone call (I NEVER WOULD TELL ANYONE'S CHILD ANYTHING, AND I NEVER RECEIVED ANY COPY OF ANY LETTER, IF IT WAS WRITTEN); parents I have never personally met, and even a parent whose child was entering the school in the fall, attacked and belittled me for being despicable; Sue Schneider, Amy Frawley, and 3 other parents were allowed by Rosa to stand up and read the first two pages of a grievance filed that afternoon against me with the school board, even though no one wanted to hear what the grievance was against Larry. And, I had never seen the grievance that these parents were allowed to read against me, so could not address any of it because I was not allowed to speak in my defense. This is a blatant violation of my rights to defend myself, and a willful attempt to inflict emotional harm. This is what I was hoping the BOE could prevent, but did not.

Roni Wattman, chair of the District 3 school board, said absolutely nothing during the meeting, and as soon as it was over gave me a copy of a letter from the school board rejecting my grievance and also gave me a copy of the grievance filed against me. The timing was extremely ironic - I filed a grievance which is rejected (and I found out today was never presented for a vote because Central Board told the school board not to vote on my grievance). At exactly the same moment I was given a grievance filed against me for deplorable actions as PTA President, all made up after I was re-elected on May 23, 2001, because I filed my grievance against Larry Lynch which no one, not even the newly established review committee, may see or discuss.

As I was shaking in stunned disbelief after the meeting, having been cut into tiny pieces by parents who are in the grips of hatred and I was not allowed to defend myself nor were my friends in the room allowed to speak,, Jose Valerio approached me and Rosa to tell me that all the PTA financial records were in Larry's office, and I should go get them. The dilemma was clear: I go to Larry's office to get the records, and I touch them and am immediately accused of stealing. Or, I do not go get them, and am accused of being derelict in my duties as PTA President. Does any one care that Larry has seriously abused me, and told me that I would be arrested if I enter the building?

Of course you know that there was a review committee set up at the meeting on June 25th. They are forbidden from looking into the allegations in my grievance against Larry Lynch, so they are sending out a survey to the entire school body over the summer asking for information on me. Why this does not concern me is: I have done nothing to warrant my removal for wrong-doing of any kind, and the establishment of the review committee is supported in the MS 54 Bylaws.

Why this review committee worries me is:

- How is this committee going to get the information on all the addresses of the parent body of MS 54? I am not even supposed to get this list, and I am PTA President. Are you, as OPAE Director at the Board of Education, going to OK the school giving out the addresses of every child who attends MS 54? Is this going to stand up in court when a parent sues the school for giving out the home address without his/her permission?
- How am I supposed to contact the teachers and staff of MS 54 who I know will support me? How do I get their summer addresses?

· Is the survey going to be mailed? Who is paying the postage?

How are parents who are away for the summer going to be contacted? Many of my

friends are in Italy right now with an Opera Company.

- How can parents read letters from fellow parents, and know what is true and what is not? Who decides? If someone writes that a parent saw me hitting a child in the hallway, dont you require the child to be interrogated? I of course deny anything as absurd as this, but these parents will do anything to cut me down. I have seen this before: if the petty things are proven as untrue, the lies get bigger and bigger.
- How do I defend my name, after parents receive questions concerning my position as PTA President and questioning my ability to be a loving mother and friend?
- After the letters somehow are sent out to everyone, and the replies come in, who verifies the information?
- Do I get copies of the letters to deny the allegations in them, or who becomes my
 executioner?

The end result of the review committee will be lawsuits, anger, a divided PTA, and the possibility that the entire school will not be able to function in the Fall. When this story hits the newspapers and television news shows, is there anyone out there who will want to stand up and speak out against anyone, ever? Will anyone want to be a PTA President? On one side I will not resign, because I think I have been the best PTA President anyone can remember, and I want to continue in the school that I love. A school aide who has worked in the office of MS 54 for years told me many times that Larry hates me because I get things done, and I create initiatives which I follow through.

The other side of the coin is that I am crushed with overwhelming unfairness,

verbal abuse, and personal attacks of the worst kind.

I have never met you, Mr. Young, but I do not feel at all protected from the bad guys out there, and I am, for the first time in my life, unsure that I will take another attack on my character, my personal beliefs, or my "job" as MS 54 PTA President without jumping ship to the side of those who want to abolish the BOE. In my grievance against Larry Lynch I presented information about his financial mismanagement, secrecy, and harassment which I still believe undermines the foundation upon which the BOE stands. By the way, is he right now doctoring the books so that he can say he actually showed me them all year?

I so need to have the attacks against me stop, but I see only an increase in the terrorizing and slander which has already spiralled out of control. All of this is totally

unfair.

Dear DJ:

After serious deliberation, I find that I must dissociate myself from the Review Process examining the charges brought against Ms. Betsy Combier as President of the M.S. 54 PTA. As such, I resign from the committee, effective immediately.

I will no longer participate in this process as I consider it fatally flawed by the composition of the committee and the continuing attempts to expand the review to any matter that might serve to justify the removal of Ms. Combier. I can not envision a manner in which this committee can conduct an impartial review of the facts surrounding the charges and render an unprejudiced report and recommendations to the general membership. I do not know if Ms. Combier's conduct rises to the level of disciplinary removal, but am unable given the "evidence" and ever expanding allegations to see how an ethical fact finding can ever be completed.

At the special meeting of the M.S. 54 PTA on June 25, 2001, several members of the committee openly demanded the ouster of Ms. Combier. Mr. Valerio publicly stated that he would resign from the position of Treasurer unless Ms. Combier was removed. Another member of the committee, Ms. Glanz, joined Mr. Valerio in writing letters against Ms. Combier's presidency prior to the convening of the committee. One member of the committee, Ms. Loretta Williams, was elected Co-President/First Vice President for the 2001/2002 school year and, therefore has an impermissible conflict of interest, as she will serve out the remainder of Combier's term in the event of removal.

In addition, I have personally been accused of a "blatantly illegal attempt to manipulate the outcome of the election," and my continued participation on the committee limits my ability to seek redress. I have received "warnings" from parents and staff members, informing me that I should remove my daughter from the Delta Program, or face the consequences. I have no need justify my conduct in this letter, but wish to show the bitterness, manipulation, and attempts at intimidation that condemn this process.

I will be in my office tomorrow (Friday 8/10/1) from noon until 5:00p. Of course you may also leave the material with the security guard if my hours do not meet your schedule.

Debi, I hope that this experience will not deter you from your wonderful volunteer efforts in the MS 54 library. Please know that your work is vital to the children of MS 54.

Dear Mr. Levy:

I am forwarding to you once again a request to stop the activities in District 3 which are now, in my opinion, prosecutable under the law.

Mr. Jamal Young at the BOE, Mrs. Pat Romandetto, Superintendant of District 3, and DJ Sheppard of the OPAE office in District 3 have refused to ask Mr. Larry Lynch, Principal of MS 54, to stop his harassment of me, a parent of an in-coming 7th grader and the PTA President.

I filed a grievance against Mr. Lynch in June, citing financial secrecy (at best) of the school account, leaving the children in the school without an extended day program. We also do not know where our Barnes & Noble check is for \$13,787.77 from Dec.13,1999 which Mr. Lynch never gave to us.

On June 25 Ms. Rosa Fenton, from the BOE, and DJ Sheppard from the District 3 office, set up an investigation into my competency because I filed a grievance against Larry. This committee is comprised of 9 MS 54 parents, and there will be hate and fingers pointed among the parent body for years to come. Parents are being threatened, and their children as well, if any one says that I am actually terrific. I have sent to you the material in previous faxes and in the mail.

Mr. Stancik gave the case to Mr. Switach, who also never looked at my grievance and sent it back to Mrs. Romandetto, who is in charge of the investigation against me for filing the grievance! Mr. Lynch never gave anyone the finished CEP which we all signed, and has now forbidden me entrance to the school or I will be arrested. He has violated numerous Sections of the A-660s, and no one cares.

Please, Mr. Levy, I need to hear from you as to what to do? The Review Committee cannot continue - my friends are suffering because they cannot judge me or anyone, and they are receiving hate email from other parents. Everybody is suffering. Larry Lynch has become worse than he ever was in his vindictiveness, and his insults.

I would like to be PTA President once again (I won re-election on May 23, 2001), because I am a fundraiser, and I just finished the 501 (C) 3 process for the PTA. I have never done anything wrong. I do not understand why Mr. Young and Ms. Rosa Fenton, Mrs. Romandetto, and DJ Sheppard are all pursuing torturing me to resign, and are not at all interested in finding out where the school allocations and CEP are.

I am not rich, and I am the mother of 4 children, all in the public school system...
must I sue the Board of Education? Cant we stop all of this before this becomes
absolutely necessary?

MS 54 / PTA Fact Sheet

As outlined in the MS 54 PTA by-laws, elections for executive board members occurred during May 2001. These officers will serve for the 2001-2 school year. Shortly after the election, information was obtained that caused five members of the association to request that the President call a special meeting. At that meeting, members questioned the ability of an executive board member to fulfill the duties as outlined in the Association's by-laws. In response to the attending members, a review committee was formed by majority vote.

The review committee is charged with the task of fact finding to determine the ability of the executive board member to fulfill the duties. It will convene on October 16. The committee will be facilitated by a mediator from *You Participate in Solutions* with Dorothy Baker-Woode, Co-Coordinator of the Office of Family and Community Engagement, also in attendance. Fact gathering will occur in the later part of October and early November, with the committee reporting its findings and recommendations at the November PTA meeting. The membership will discuss the review committee's recommendation, and make a decision at the November meeting.

In order to provide technical assistance and to facilitate collaboration at MS 54:

- a parliamentarian will be present at future PTA meetings;
- Dorothy Baker-Woode and DJ Sheppard, Co-Coordinators of the Office of Family and Community Engagement, will attend executive and general PTA meetings;
- Jay Hecht and Dr. Myrna Levine, Community School District 3 staff will be attending School Leadership Team meetings.

Through a grant obtained by the district, *Every Person Influences Children* (EPIC) will be actively recruiting parents, providing workshops on parent leadership skills and building capacity through EPIC's *Home/School Partnership* program. Paula Pringle, EPIC program coordinator assigned to MS 54, will begin workshops in early November.

As per our conversation yesterday, I am sending you this letter to request a xeroxed copy, both front and back, of the check which was sent to Booker T. Washington MS 54 in February, 2000. The check was issued by Barnes & Noble and was made out to Booker T. Washington MS 54 for a PTA fundraiser on December 13, 1999. The amount was \$13,783.77.

I am requesting a copy of this check because I, as PTA Co- Chair for the MS 54 PTA, signed the contract along with Ms. Meredith Millich for the MS 54 PTA fundraiser at Barnes & Noble on December 13, 1999. I wrote the flyers and had 5000 of them made in gold and green, and worked, with 30 other terrific parents, from 9AM to 9PM. It was a wonderful day. When we heard that we had made a record amount of \$13,783.77, we were indeed thrilled.

However, we never saw the check, and never received any of the money raised that day. I have been working non-stop since February, 2000, to find out what happened, and how the MS 54 PTA may profit from the hard work of so many parents. I filed a Verified Petition with the New York State Board of Regents' Office of Counsel against Mrs. Patricia Romandetto, Superintendant of District 3, at the end of September, 2001, to uncover the mystery surrounding the Barnes & Noble check. I am the "Attorney", or Petitioner, in this case. As such, I would appreciate your sending to me at your earliest convenience the front and back of the Barnes & Noble check for \$13,783.77 made out to, according to your statement made yesterday, "Booker T. Washington MS 54". I must incorporate this information into my documents filed in Albany with the Commissioner.
