Dear Ms. Weinstock:

For seven years I have been stalked and harassed by the people listed below, in retaliation for my mom and I "knowing" what Madison Avenue Presbyterian Church is doing, which seems to be laundering money under the umbrella of "church".

For 5 years I have tried to find out what the MAPC Federal ID number is, which would make it a recognized charity. I and the several people who have helped me on this quest have never found one. MAPC is not listed as a charity with the Charities' Bureau, and the IRS has never heard of this entity.

The Federal ID numbers of two other Presbyterian churches in the New York City area are (according to the people listed below):

The Presbytery of New York City (475 Riverside Drive) is in on the scheme. Cornell Edmonds is the Stated Clerk who handles business. The "legal" arm of the Presbytery is the Permanent Judicial Committee, comprised of lawyers from the biggest law firms in the city along with church Elders and Deacons. I have names of the PJC members who have been part of my case.

I am not fabricating anything, and I am not telling you all of this to "get back at" anyone. I believe that this scheme is a massive criminal operation that needs to be stopped.

My mom, Julia Taschereau, had an office on the 7th floor of MAPC for more than 20 years. She was a volunteer and worked there for more than 40 years, first with Dr. Read, and then, since 1992, Dr. Fred Anderson. My mom loved her job there, and she did not want to jeopardize it by saying anything, but she was an excellent "sleuth" and had 45 ears. She told me everything that I now tell you.

When Dr. Fred Anderson arrived in 1992 it was said that he was brought in to "handle th money". MAPC has an endowment between \$20-36 million, depending on who you speak to. Every year through donations the church receives about \$1.5 million in donations, and about \$25,000 in cash at the Sunday services. We, the congregation, receive an accounting every January at the annual congregational meeting. Last year the accounting was done by Austin Bartlett here in New York. I spoke with Sandy Davies (212-286-2600) at O'Connor Davies, Arthur Gallagher (518)393-9121 and Laurie Cross (888)250-6689 trying to find out what was going on but could not get anywhere.

Guide One Insurance Company is the insurance company for the church, and the main office is in West Des Moines Iowa. Peggy Mundy is in charge of the litigation office, and she is the person who hired and pays the Law Firm of Michael E. Pressman, Attorney Kenneth Wasserman, and Attorney Jonathan Landsman to prosecute me "in the interests of the church" she told me.

Almost three years ago Ms. Mundy called me and asked me if I would take \$1 million to stop looking into what MAPC was doing. I told her I would consider it, but she would have to speak with a lawyer I had just hired. She told me that she didn't know that I had a lawyer, and hung up. That was the last I heard about that.

Please look at the more than 300 pages of documentation I have given to you, and please stop this scheme which to me, a citizen and member of MAPC, looks like embezzlement.
